Any late payment approved and accepted by the Soccer Committee Chair after the deadline date will pay an additional inconvenience fee of \$50.00 on top of regular fees.</li> <li>4. All fees do NOT include any parking/admission entry. All sports players and coaches <b>MUST pay their own parking pass upon arrival and park in the general parking areas as directed by the Traffic Team.</b></li> </ol>

This is an outdoor event, if it shall be cancelled by order of a governmental agency for public health and safety reasons due to weather safety, HCCC will refund its full payment to Applicant/Coach.</li> <li>2. If coach and team do not violate any terms of playing, rules/regulations, or get into physical altercations with other teams, they may be eligible to receive back their deposit fee only. This will be determined by the Soccer Committee Chair.</li> </ol>
<p><b>Cancellation Policy</b> Initial below on the line.</p> <hr/>	<p>A cancellation refund request must be submitted in writing to the Soccer Committee Chair and eligible per the below reasonings, by September 13th, 2026 –DEPOSIT FEE is non-refundable.</p> <p>Cancellation eligibility:</p> <ol style="list-style-type: none"> <li>1) The captain or coach is hospitalized - proof from a doctor/hospital.</li> <li>2) Death in the immediate family - proof from funeral home/death certificate.</li> <li>3) Other Emergency - must be team related and need documentation proof of some sort.</li> </ol> <p><b>**Any No Show results in forfeiture and all fees paid are non-refundable.</b></p>
<p><b>Violations Policy</b> Initial below on the line.</p> <hr/>	<ol style="list-style-type: none"> <li>1. Coach and players may be removed, fined, and/or penalized for behaving in a manner deemed to be inappropriate, disruptive, unsafe, disorderly, or illegal by La Crosse County Health Department, Veteran’s Memorial Park grounds, La Crosse/West Salem Police &amp; Sheriff’s Department, and La Crosse/West Salem’s Fire Department. Coach and players will forfeit all fees paid at this time.</li> <li>2. <b>No illegal or alcoholic products allowed during the event at any time!</b></li> <li>3. <b>Please thoroughly read the Sports Rules and Regulations document for more information.</b></li> </ol>

4. Coach and players hereby agree to indemnify and cannot hold HCCC and the New Year Committee from claims, liabilities, losses, damages, and injuries while voluntarily participating in this event at the Hmong New Year Festival.
5. HCCC and the New Year Committee is not liable for any losses due to natural disasters, criminal activities, and/or negligent acts.
6. HCCC and the New Year Committee reserves the right to cancel this Agreement at any time if Coach and/or players are conducting themselves in a manner that is harmful, unlawful, or unsafe while at the Festival.
7. Coach and players are voluntarily and willingly signing up to participate in the soccer tournament for the 2026 La Crosse Hmong New Year Festival assuming all risks during the activity and acknowledges that HCCC and the New Year Committee will not be held responsible for any personal liability, risk, harm, injury, and illness.
